#### March 25, 2024

#### 1. Call to Order and Introduction of Those Present

Recognizing a quorum, Richard Zink called the meeting to order at 9:32 AM. Introductions were made of those present.

#### 2. Change of Order of Business

The Board adopted a resolution approving a change in the order of business (Havey, Kerper, passing unanimously).

#### 3. Presentation of Audit

Mr. Edward Bysiek of Bysiek CPA, PLLC presented the audit, including the management letter, for the year ending December 31, 2023, to the STERA Board. The audit indicated an unqualified (clean) opinion and did not find any deficiencies or weaknesses in STERA's internal control procedures for the year ending December 31, 2023, or any compliance findings for the year ending December 31, 2023. After discussion, the Board adopted a resolution accepting the audit for the year ending December 31, 2023 and the accompanying management letter (Havey, Kerper, passing unanimously).

#### 4. Approval of the Minutes of the October 16, 2023 and October 2, 2023 Meeting

The Board adopted a resolution approving the minutes of the October 16, 2023 Board Meeting and the October 2, 2023 Board Meeting (Kerper, Kerper, passing unanimously).

#### 5. Communications

STERA has received communications from New York State Department of Transportation stating that STERA was awarded \$1,947,550.00 for the 2023 STERA PFRAP Ties and Decks Allegany to Niobe project.

STERA also received a letter from Steuben County naming Paul Van Caeseele as a member of the STERA board replacing John Malter.

STERA also received an email concerning the desire of Congresswomen from Ohio to explore Amtrak running service from NYC to Chicago.

There were no other communications.

#### 6. Treasurer's Report

Mr. Zink presented the Treasurer's Report for February 28, 2024. For the year to date ending February 28, 2024, STERA had a net income of \$342,137.81 on revenues of \$342,137.81. As of February 28, 2024, STERA had net assets of \$2,666,329.22 on assets of \$2,666,329.22, with a cash balance of \$80,192.22.28. Accounts payable as of February 28, 2024, were \$28,000, and accounts receivable as of February 28, 2024 were \$40,000.00. He discussed elements of the accounts receivable. The Board adopted a resolution approving the Treasurer's Report for February 28, 2024 (Barnes, Dixon, passing unanimously).

The Board adopted a resolution approving the payment of the following four checks:

\$85,000.00 to Southern Tier West for administrative services \$3,000.00 to Bysiek CPA, PLLC for audit services \$6,842.75 to Southern Tier west for construction administrative services

\$1,150.00 to RONY (Railroads of New York)

(Barnes, Dixon, passing unanimously).

#### 8. WNYP RR Operating Status Report

Andrew Lawton (Chief Engineer) from the WNYP RR, provided a Management Report to the STERA Board. The Management Report covered the areas of Safety and Security, Grant Activities, Real Property, Operations and Customer Service, Marketing and Freight Business, Mechanical Issues, and Engineering and Maintenance of Way.

#### A. Active Projects:

#### 1) Active Projects:

NYSDOT PFRAP Bridge Repair and Tie Installation Project (Southern Tier Extension Line and Buffalo Line) - should be completed in 2024

NYS DOT PFRAP Olean Enginehouse and Yard Improvement Project • STERA Tie and Rail
Replacement PFRAP Project (Southern Tier Extension Line) – should be completed in 2024

NYSDOT PFRAP Track and Bridge rehab (Queen Street) – may have some remaining work in 2025

NYSDOT PFRAP Allegany to Niobe – should begin in 2024 and be completed in 2025.

#### B. **Proposed Projects**

## <u>Proposed Bridge NY Project (Salamanca Main Street Bridge Replacement and Track Realignment, Southern Tier Extension Line)</u>

In 2017, STERA had discussions with the City of Salamanca and he Seneca Nation of Indians regarding a project that would involve replacement of the Salamanca Main Street rail bridge (replacing the 6 lane rail bridge with a two lane bridge, with higher clearance for Main Street underpass traffic) and the realignment of track just to the west of the bridge (re-routing of the main line in this area to remove the curvature of the line, which is a safety issue and which keeps train speeds down). Such a project (or at least the bridge replacement component) would be eligible for NYS DOT Bridge NY funding. The project grant application would not be submitted until a future year. The Seneca Nation of Indians representatives indicated that there would have to be approval by the Seneca Nation of Indians for both the bridge and track realignment projects to move forward.

#### 10. Seneca Nation of Indians Representation on STERA Board

Angie Kennedy represented the Seneca Nation of Indians at the meeting.

#### **Compliance Status – NYS ABO Training Requirements**

Mr. Zink noted that all STERA Board members and staff are in compliance with NYS ABO training requirements with the exception of Mr. Barnes.
